- 4. The Applicant, by becoming a member, assumes no personal liability or responsibility for any debts or liabilities of the Cooperative, and it is expressly understood that his private property is exempt from execution for any such debt or liabilities.

Such capital credits are hereby assigned, from time to time as they become payable, to the Cooperative in the event and only in the event that the Cooperative has been unable to pay such amount(s) to the undersigned within three years after they become payable after the Cooperative’s bona fide attempt to pay such funds (whether by mailing letters to last known address of the undersigned member or his heirs on the books of the Cooperative or otherwise).”

SECTION 8.04 Voluntary Capital Credit Assignment Agreement. Following a determination by the Board that a Voluntary Capital Credit Assignment would be beneficial to the Cooperative, the agreement form was mailed on December 7, 1979 to all active subscribers. After that date, new subscribers are asked to make the assignment upon application for telephone service with the Cooperative. If the Cooperative is unable to locate members for three years, the bylaws provide that the Capital becomes a gift to the Cooperative being returned to the general funds of our total membership. In the Cooperative’s Newsletter, members will be asked to take the time to look over the list of names of members who are entitled to capital credits and who the Cooperative has been unable to reach at the last recorded address.

Purpose of Form

A person who is required to file an information return with the IRS, must obtain your correct taxpayer identification number (TIN) to report, for example, income paid to you, real estate transactions, mortgage interest you paid, acquisition or abandonment of secured property, cancellation of debt, or contributions you made to an IRA.

U.S. person. Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN to the person requesting it (the requester) and, when applicable, to:

1. Certify that the TIN you are giving is correct (or you are waiting for a number to be issued),
2. Certify that you are not subject to backup withholding, or
3. Claim exemption from backup withholding if you are a U.S. exempt payee.

In 3 above, if applicable, you are also certifying that as a U.S. person, your allocable share of any partnership income from a U.S. trade or business is not subject to the withholding tax on foreign partners' share of effectively connected income.

Note. If a requester gives you a form other than Form W-9 to request your TIN, you must use the requester's form if it is substantially similar to this Form W-9.

For federal tax purposes, you are considered a person if you are:

- An individual who is a citizen or resident of the United States,
- A partnership, corporation, company, or association created or organized in the United States or under the laws of the United States, or
